1	Page 6, Point No. 3, Eligibility of Bidders	The following 2 new points are being added in the Eligibility Criteria: (i) It is mandatory for the Bidders to have their own in-house state-of-the-art Tea Packaging Unit having all the requisite facilities for cleaning, sorting, grading, packaging etc. of the teas. The Packaging facilities owned by the Bidders will be examined by Tea Board officials by visiting the packaging plant on-site. (ii) It is mandatory for the Bidders to submit their quotations for all the goods and services mentioned in the Tender document, and fill in all the corresponding Financial Bids/BOQs. Failure to comply with this point will result in disqualification of the Bidder.
2	Page 14, Point no. 7.1.v) Packaging of Corn Starch Pyramid Tea Bags in small size metal tea caddies (containing 10 corn starch pyramid tea bags, each tea bag having 2 gms of tea)...	The following amendment is being made, both in the Technical Specifications for the Tea Bags and in the corresponding Financial Bid-V/BOQ-V: Packaging of Nylon Pyramid Tea Bags in small size metal tea caddies (containing 10 nylon pyramid tea bags, each tea bag having 2 gms of tea)...
3	Page 21, Point no. 7.3	The following addition is being made: The rate for packaging of the metal tea caddies should be inclusive of the cost of shrink-wrapping of the caddies.

4	Page 22, Point no. 7.4, Packing of Tea	The following new point is being added in the Packing specifications: All the tea caddies and poly standy packs being supplied to Tea Board or being dispatched to various destinations as per indent given by Tea Board have to be packed in 5-ply CFC Master Cartons.
5	Page 23, Point no. 7.7, Specifications for the lid of the metal caddies	The line “The lid should have inner plastic inserts containing silica gel sachets of 2 gm. These silica gel sachets should be Desiccant (DMF free)” is being deleted, both in the specifications for large size and medium size caddies.. The contractor will not have to include silica gel sachets in the lids.
6	Page 24, Point no. 7.9	A new point – Point no. 7.9 is being added: Samples of all the items to be supplied by the Bidders as specified in the Tender document may be seen by the Bidders at Tea Board. The selected Bidder will have to share samples of all the items mentioned in the Tender document. Approval must be taken from Tea Board for the new samples prepared by the selected Bidder as per the Tender specifications, before commencement of final production.
