The quotations received in time will be opened at 04:00 PM on the same day i.e., 20/11/2017 in the conference hall at 3rd Floor, Tea Board of India, Siliguri, West Bengal. The bidders or their representatives, not more than one for each quotation, may be present, if they so desire, at the time of opening of the quotations. The cover should be prominently superscripted with the words "Quotation for purchase of Condemn Vehicle".

- 3. The vehicles will be available for inspection between 03:00 PM to 04:00 PM on 14th and 15th November, 2017 at Board's Jalpaiguri Office located at "Malayala", 439/310/C Hakimpara, Ward No.03, Jalpaiguri 735 101.
- 4. The Auction of said vehicles will be governed by the following conditions:-
 - I. The bidders are required to pay the Earnest Money of Rs. 4000/- (Rupees four thousand only)
 - II. The earnest money is payable by means of Demand Draft in favour of "Tea Board", payable at Kolkata. (Payment by cash or cheque shall not be accepted)
 - III. Quotations received without the demand draft towards the earnest money will not be

considered and shall be rejected.

- IV. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Tea Board, payable at Kolkata within two working days of the acceptance of the bid.
- V. The earnest money of the successful bidder will be released only after the deposit of the bid amount. Earnest money will not be adjusted as bid amount and will be forfeited, if he fails to honour the bid.
- VI. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits the documentary evidence in support of their residential status (Voter ID. AADHAR Card etc., in case of individual and Registration certificate etc., in case of firms)
- VII. The auctioned vehicles will be removed by the successful bidder within 02 working days of depositing the bid amount, at their own expenses
