- 2 The Lowest price will be selected and offer will be given to L-1 bidder to supply the vehicle.
- 3 The service should be provided at the places mentioned in the scope of work. The price should include GST, all Taxes, charges and expenditure whatsoever, no extra payment **other than the quoted price** will be paid for the delivery of the services.
- 4 The service should be delivered immediately from the issuance of work order.
- 5 A sum Rs.4,000/- (Rs. four thousand only) on account of Earnest Money deposit shall be deposited through DD/Pay Order or electronic transfer in favour of "Tea Board Imprest Accounts" A/c No. The proof of depositing EMD should be attached with the quotation.
