- 1. Sealed Quotations are required to be submitted in the Quotationer(bidder)'s own Letter Head Pad duly signed and stamped with date.
- 2. Before submission of the offer the indenting Packer & Mover Agency/ company is required to inspect the furnitures to see the items thoroughly, volume etc..
- 3. The price quoted must be firm and offer quoted must remain valid for acceptance for 180 days from the date of opening of the bid; and offer must be for the entire work.
- 4. Tea Board Authority reserves the right to accept/reject any offer without assigning any reason thereof. Tea Board also reserves the right to accept any offer wholly or in part at its option. Bidder shall have to supply/provide services at quoted rate only.
