Name of work: Repairing of 15.95 sq.mt (approx) shutter of main gate at Ground Floor in Tea Board H.O

The estimated cost of work is Rs. 20,700/- (approx) inclusive all applicable taxes & charges. Earnest money to be deposited along with the quotation amounting to Rs. 450/- in the form of D.D/Pay order of the schedule Bank in favour of Tea Board, Kolkata. Quotation shall be addressed to the Secretary, Tea Board 14, BTM Sarani, Kolkata 700 001 West Bengal and deposited in the tender box at 8<sup>th</sup> floor of the Tea Board within seven days from the date of publication of quotation in the Board's website by 1-00 PM and same will be opened at 3-00 PM on the same day in presence of willing quotationers.

Specification of work shutter gate opening and refitting using by parts for repair & replacement of pulley, MS Patti 1/1 20 ft as required then re-fixing the same in position after necessary repairs/replacement in all complete for smooth opening & closing. Quotationers must quote their rates in lump sum amount to evaluate for the entire work.

The quotationers shall quote his price in lump sum of the schedule of quantity both in figures and in words clearly. The price quoted shall include the cost of all labour, materials, transportation cost with taxes, VAT and Other duties, lead, lift, loading and unloading, freight for materials and all other charges necessary for completion of the works on time. For which the quotationers must visit the site to check and verify the area for which quotation is invited before submitting quotations. In case of any damage of permanent structure/property of Tea Board during the execution/progress of work, suitable penalty at double prevailing rate of the item will be proportionately deducted from bills and holdings up bills until the claim of Tea Board for mending good damages, if any, are settled and damaged part restored as required at own cost of the agency.
