Food Safety & Standards Regulations, 2011- The New Mandate

Ministry of Health and Family Welfare, under the Food Safety and Standards Act (FSSA), 2011, has set up Regulatory Guidelines for all organizations managing food and beverage operations to implement Good Hygiene Practices, Good Manufacturing Practices and fulfil the requirements of Codex HACCP guidelines.

It will thus be important for all food organizations to be aware about the challenges they will be facing with the enforcement of Food Safety & Standards Act (FSSA) which has come into force, from Aug 5, 2011. As per the act, all Food Establishments and Manufacturing Units have to procure either Licence or get them registered with FSSAI as per their turnover, prior to 4th August 2012.
